**Terms of Reference:** The Committee shall:

1. Supervise the functioning of the school in all aspects including academic performances, infrastructure development, co-curricular activities, mess etc.
2. Assist the schools in ensuring local assistance and cooperation for its better working and growth.
3. Assist in organizing various activities for children to know about their culture, about various avenues for their personal and professional growth.
4. Mobilize public support by way of additional financial support and kind for strengthening the activities of the schools.
5. Organize activities to make schools a focal point for improvement in quality of school education in general through sharing of experiences and facilities.

6. Monitor the progress of various infrastructure development activities in the schools.
7. Provide suggestions to the State EMRS Society on any improvement or reform required in the academic or other aspects of functioning of the schools.
8. Handle any other responsibility to be assigned by the State EMRS Society.
