In pursuance to the above-mentioned advertisement notice dated 10.07.2023 and as per the recommendation of the UT Level Selection Committee for the selection of State Coordinator under UDID Project, sanction is hereby accorded to the temporary appointment of candidate as mentioned below for the post of State Coordinator under UDID.

The candidate engaged shall report to the office of Director, Social & Tribal Welfare Department, UT of Ladakh, along with the requisite documents. Further, the office of the State Coordinator under the said Project shall be located in the office premises of State Commissioner for Persons with Disabilities, UT Ladakh/ Director, Social & Tribal Welfare Department, camp office Leh.

The engagement shall be subject to the following conditions:

**Terms & Conditions:**

1. The appointment is purely on contractual basis and continuous/renewal of contract shall not confer any right of claiming regularization/permanent absorption against the post.
2. The appointee shall join within a period of 07 days from the date of issue of this Order. In case the candidate fails to join within the stipulated period, without any justifiable reason, the engagement order shall be treated to have been cancelled ab-initio in respect of such candidate and the waitlist shall be initiated.
3. The candidate shall be allowed to join on production of the following certificates (in original)
  - i. Qualification Certificate viz. Degree/Marks.

- ii. Date of Birth Certificate
- iii. Certificate from the concerned authority to the authority to the effect that no loan under self-employment scheme has been taken by the concerned.
4. The candidate shall execute an agreement through a prescribed affidavit duly executed/sworn before learned Judicial Magistrate to the effect that he will have no claim any right for any sort of permanent absorption/regularization in the Administration at any later stage.
5. Director Social & Tribal Welfare Department, UT of Ladakh shall get the character antecedents of the appointees verified from the competent authority and in the event this office receives any adverse report with respect to the character antecedents or documents/certificates furnished produced by the candidate, the engagement order shall be treated to have been cancelled ab initio and criminal proceedings shall be initiated against candidate.
6. The contractual appointment shall be valid for one year or as may be extended by the Department based on the directions from Ministry of Social Justice & Empowerment, DEPwD.
7. At the end of the above referred period, the contractual appointment will stand terminated automatically without any notice or communication, unless they are explicitly extended by the issuing authority by an order in writing.
8. The Department can terminate the service of State Coordinator without any notice.
9. The staff shall be eligible for 12 days leave in a calendar year, thereafter remuneration would be deducted on pre-data basis.
10. After joining the duty, the appointee has to serve a notice of 30 days minimum for resigning, or will pay gross salary (inclusive of all allowances) of the equivalent period in lieu of the notice.


