  - b) *They are otherwise found ineligible or unsuitable to be retained in the service.*
2. *The above appointees have been declared medically fit by the Prescribed Medical Authority.*
  3. *This appointment is subject to the verification of character and antecedents; verification of the certificates of reserved category; and verification of certificates / marksheets relating to the educational qualification and such essential requirements as prescribed in the Ladakh Health and Medical Education Department Subordinate Service Recruitment Rules, 2021.*

1. *The services of the above candidates appointed as **Orderly/Chowkidar** placed at the disposal of the Chief Medical Officer, Leh for further deployment in the Sub-ordinate Offices of the Health and Medical Education Department, Leh.*
