Whereas, vide the above-referred notification dated 08.02.2024, the Leh Autonomous Hill Development-Subordinate Services Recruitment Board (LAHD-SSRB) has issued a selection list in favour of Six (06) candidates in the Revenue Department of the Administration of Union territory of Ladakh, under District Cadre of Leh District, in Pay Level-4 of structure (Rs. 25500-81100);
