In terms of Rule (6) of Central Services (Medical Attendance) Rule 1994 read with O.M vide No. S.14025/24/2023-EHS dated: 15.01.2024 of the Ministry of Health & Family Welfare Government of India, sanction is hereby accorded to the reimbursement of medical expenses to the tune or **Rs. 2,50,430/= (Rupees, two lacs fifty thousand four hundred and thirty only)**, incurred by Sh.
