### Circular

In reference to the aforementioned letter regarding the issuance of seniority, it has been observed that, after the apportionment of manpower between the Union Territory (UT) of Jammu & Kashmir and the Union Territory (UT) of Ladakh, the separate seniority list of non-gazetted (UT Cadre) employees of the Horticulture Department has not been maintained as on date.

**Whereas, S.O 53 dated: 12-10-2023, (Rule 10),** Union Territory of Ladakh Horticulture (Subordinate) Service Recruitment Rules 2021, provides the provision for the maintenance of the seniority list of the members of the service (other than district cadre) from time to time by the Administrative Department.

**Therefore,** a tentative seniority list of Grading & Marketing Inspector Non-Gazetted Officials (UT Cadre) in the Horticulture Department, UT of Ladakh, as of 31-03-2024, is hereby notified, and attached as Annexure 'A' to this circular.

**Accordingly,** employees / officials in the Horticulture Department, UT of Ladakh, are hereby given the opportunity to make representations to the Administrative Department. If any official /employee is aggrieved by their assigned position or has not been included in the tentative seniority list, they should submit their representation with supporting documents within 15 days from the date of issuance of this circular.

**In case,** an official chooses not to file any objection, it shall be construed that there is nothing objectionable against the seniority position. The final seniority list of officials in the Horticulture Department, UT of Ladakh, shall be issued accordingly with the approval of the competent authority.
