In terms of Rule (6) of Central Services (Medical Attendance) Rule 1994 read with O.M vide No. S.14025/24/2023-EHS dated: 15.01.2024 of the Ministry of Health & Family Welfare Government of India, sanction is hereby accorded to the reimbursement of medical expenses to the tune of ₹ 3,00,549/=(₹ Three lakh five hundred forty-nine only) incurred by Sh. Ashwani Kundal, Junior Engineer of PW(R&B) Division, Leh, presently posted in Ladakh Bhawan, Chandigarh for undertaking his medical treatment of his mother at Government Medical College & Hospital, Chandigarh.

The above sanction shall be subject to the following conditions:

iii. All relevant certificates required as per rules are obtained by the concerned Drawing & Disbursing Officer.
