**Whereas,** Staff Selection Commission (SSC) vide the above referred notice dated 05.02.2024, inter-alia others recommended the name of Mr Tashi Namgyal S/o Sh. Sonam Stobgais R/o Kungyam Hemya, Leh for appointment as Driver Grade-II in the Administration of UT of Ladakh in the Pay Structure (₹19900-63200) Level-2 of pay matrix.

**Whereas,** in pursuance of the above-referred Provisional Select List, and in accordance with para 18.22 of the Advertisement Notification Selection Post/Ladakh/2022, the General Administration Department (GAD), vide Memorandum issued under file No: A/12/2/2021/O/o Un Secy GAD dated: 23.02.2024, sought the preference of Departments for the post of Driver Grade-II from the provisionally selected candidates.

**Whereas,** based on the preference given by the candidates, considering their merit in the select list, GAD, vide Order No: 138 LA(GAD) of 2024 dated: 15.03.2024, inter-alia others Mr Tashi Namgyal has been allocated to GAD.

**Whereas,** accordingly GAD under File No. A-12/17/2024-GAD SEC dated:16.03.2024, had issued an "Offer of Appointment" in favour of Mr Tashi Namgyal as Driver Grade-II in the Pay Structure ( ₹ 19900-63200) Level-2 of the pay matrix, wherein a period of thirty (30) days was given to him to accept the offer.

**Whereas,** on 03.04.2024 Mr Tashi Namgyal submitted an undertaking declaring therein his unwillingness to join for the post of Driver Grade-II in GAD.



**Now, therefore,** in light of the above, the 'Offer of Appointment' issued in favour of Mr Tashi Namgyal as Driver Grade-II in GAD is hereby deemed to have been cancelled *ab-initio*.
