- ii). The Salary of the appointee shall be drawn and disbursed to them after receipt of the verification report from the competent verifying agency, viz, CID.
- iii). The appointee shall be on probation for a period of two years.
- iv). The seniority of the appointee in the Ladakh Economics & Statistics (Subordinate) service shall be determined as per the select list rank issued by the Staff Selection Commission.
- v). The appointment of the candidate shall be subject to the outcome of writ petition (s), if any, pending before the Competent Court of Law, which may not be presently within the knowledge of the Department.
