  - On the basis of his / her performance or conduct, he / she is considered unsuitable for further retention in service, or
  - He / She is otherwise found ineligible or unsuitable to be retained in the service.
- The above appointees have been declared medically fit by the Prescribed Medical Authority.

3. *This appointment is subject to the verification of character and antecedents; verification of the certificates of reserved category; and verification of certificates / marksheets relating to the educational qualification and such essential requirements as prescribed under the Union Territory of Ladakh Agriculture (subordinate) Service Recruitment Rules, 2022).*
