- 1. The above appointee shall be on probation for a period of two year with effect from the date of their joining the post. During the period of probation, the appointee will be liable to be discharged from service at any time without any notice, if:
  - (a) on the basis of his/her performance or conduct, he/she is considered unsuitable for further retention in service, or
  - (b) he/she is otherwise found ineligible or unsuitable to be retained in the service
- 2. The above appointee has been declared medically fit by the Prescribed Medical Authority.

- 3. The appointment is subject to the verification of character and antecedents; verification of the certificates of reserved category; and verification of certificates/marksheets relating to the educational qualification and such essential requirements as prescribed in Union Territory of Ladakh Sheep Husbandry (Subordinate) Service Recruitment Rules, 2021.
- 4. Other conditions of service will be governed by the relevant rules and orders in force from time to time.
