- b) He is otherwise found ineligible or unsuitable to be retained in the service.

- This appointment is subject to the verification of character and antecedents; verification of
 the certificates of reserved category; and verification of certificates / marksheets relating to
 the educational qualification and such essential requirements as prescribed in the Ladakh
 Health and Medical Education Department Subordinate Service Recruitment Rules, 2021.
