  - b) *He / She is otherwise found ineligible or unsuitable to be retained in the service.*
2. The above appointee has been declared medically fit by the Prescribed Medical Authority.

This appointment is subject to the verification of character and antecedents; verification of the certificates of reserved category; and verification of certificates / marksheets relating to the educational qualification and such essential requirements as prescribed in the Union Territory of Ladakh Industries & Commerce (Subordinate) Service Recruitment Rules, 2021.


