Consequent upon the recommendation made by Leh Autonomous Hill Development – Subordinate Services Recruitment Board (referred above), against the Post of Phase – II (Matriculate & 10+2 Level) of Advertisement Notice No. 02 of 2022, Dated: -30/11/2022 and with the approval of the Competent Authority/ Appointing Authority, the belowmentioned candidates are hereby appointed to the post of **Forest Guard (Group 'C', Non-Gazetted)**, in the Department of Forest, Ecology and Environment of the Administration of Union Territory of Ladakh **in Level-2 of pay matrix (Rs. 19900-63200)** and other allowances as admissible under the Rules, with immediate effect: -

#### The appointment shall be subject to the following conditions: -

- 1. The above appointees shall be on probation for a period of two years with effect from the date of their joining the post. During the period of probation, the appointees shall be liable to be discharged from service at any time without any notice, if:
  - a) On the basis of his/her performance or conduct, he/she are considered unsuitable for further retention in services, or
  - b) He/she are otherwise found ineligible or unsuitable to be retained in the service.

- 2. The above appointees have been declared medically fit by the Prescribed Medical Authority.
- 3. This appointment is subject to the verification of character and antecedents; verification of the certificates of reserved category; and verification of certificates / mark sheets relating to the educational qualification and such essential requirements as prescribed in the Union Territory of Ladakh Forest (Territorial) Subordinate Services Recruitment Rules, 2022.
- 4. Other terms and conditions of service will be governed by the relevant rules and orders in force from time to time.
- 5. The *inter-se* seniority of the above appointees shall be worked out as per rules.
- 6. The appointment of the above appointees shall be subject to the outcome of writ petition (s), if any, pending before any competent Court of law.

### It is further ordered that:

- 1. The services of the above candidates appointed as **Forest Guard** are placed at the disposal of the **Chief Conservator of Forests**, **UT of Ladakh** for further deployment in the Sub-ordinate Offices / Divisions of the Forest Department of UT Ladakh.
- 2. The appointees shall report to the Office of **Chief Conservator of Forests**, **UT of Ladakh** for joining within a period of one (01) month from the date of issuance of this Order, failing which his/her appointment shall be deemed to have been cancelled *ab initio*.
- 3. The expenditure towards their pay and allowances shall be debited against the head of "Salaries" from the Budget Head associated with their respective place of posting upon their deployment in the Sub-ordinate offices of the Forest Department.
