S.O. .— In exercise of the powers conferred by S.O 282(E) dated 21-01-2020, the Hon'ble Lieutenant Governor of Union territory of Ladakh, hereby makes the following amendments in the Union territory of Ladakh Food Civil Supplies & Consumer Affairs (Subordinate) Service Recruitment Rules, 2021, notified vide S.O 63 dated 3-12-2021, namely,-

- In Schedule-II (B). —**
- (i) In the 5th row, for the 3rd column under the heading minimum qualification for direct recruitment the following shall be inserted;
“Graduation from any recognised University.”
 - (ii) In the 5th row, for the 4th column under the heading method of recruitment the following shall be substituted:
 - i. 50% by direct recruitment;
 - ii. 50% by promotion from Weighman/ Watchman/Chowkidar and Helper in order of common seniority, minimum 10th pass, and having not less than five (05) years substantive service.

Note: *The incumbent Orderlies as on notification of these Rules shall also be eligible.*
