  - b) *He/She is otherwise found ineligible or unsuitable to be retained in the service.*
2. *The above appointee has been declared medically fit by the Prescribed Medical Authority.*
3. *This appointment is subject to the verification of character and antecedents; verification of the certificate of reserved category; and verification of certificates/marksheets relating to the educational qualification and such essential requirement as prescribed in the Union territory of Ladakh Motor Vehicle Department (subordinate) Service Recruitment rules, 2021.*

1. The services of the above candidates appointed as **Motor Vehicle Inspector** is placed at the disposal of the regional Transport Officer (RTO) Ladakh, Leh for further deployment in the Sub-Ordinate Offices of **Motor Vehicle Department Ladakh.**
2. The appointee shall report to the **Regional Transport Officer (RTO) Ladakh**, for joining within a period one (01) month, from the date of issuance of this Order, failing which his/her appointment shall be deemed to have been cancelled ab-initio.
3. The expenditure towards pay and allowances shall be debited against the head of "Salaries" from the Budget Head associated with his/her respective place of posting jupon his/her deployment in the Sub-ordinate Office of **Motor Vehicle Department Ladakh.**
