1. *The appointee shall be on probation for a period of two years from the date of joining the post. During the period of probation, the appointee will be liable to be discharged from service at any time without any notice, if:*
 - a) *On the basis of his/her performance or conduct, he/she is considered unsuitable for further retention in service, or*
 - b) *He/She is otherwise found ineligible or unsuitable to be retained in the service.*
2. *The above appointee has been declared medically fit by the Prescribed Medical Authority.*
3. *This appointment is subject to the verification of character and antecedents; verification of the certificate of reserved category; and verification of certificates/marksheets relating to the educational qualification and such essential requirement as prescribed in the Union territory of Ladakh Motor Vehicle Department (subordinate) Service Recruitment rules, 2021.*



It is further ordered that;

1. The services of the above candidates appointed as **Junior Assistant** is placed at the disposal of the regional Transport Officer (RTO) Ladakh, Leh for further deployment in the Sub-Ordinate Offices of **Motor Vehicle Department Ladakh.**
2. The appointee shall report to the **Regional Transport Officer (RTO) Ladakh**, for joining within a period one (01) month, from the date of issuance of this Order, failing which his/her appointment shall be deemed to have been cancelled ab-initio.
3. The expenditure towards pay and allowances shall be debited against the head of "Salaries" from the Budget Head associated with his/her respective place of posting jupon his/her deployment in the Sub-ordinate Office of **Motor Vehicle Department Ladakh.**
