Sanction is hereby accorded to the temporary appointment of Ms. Skarma Tashi Diskit D/o Late Constable Sonam Wangyal No. 711/IRP 4<sup>th</sup> R/o Alchi, Tehsil Saspol District Leh as "Constable" in the pay level L-2 (19900-63200) in the Ladakh Police (Subordinate) Service, in terms of Rule-7 of SRO-43 of 1994 read with S.O. 23 dated 14.08.2020 of GAD UT Ladakh.

The appointee shall report to the Head of Police, UT of Ladakh, within a period of 21 days from the date of issuance of this Order and shall be allowed to join only on the production of the following documents/certificates (in original) to be verified subsequently:

- i. Academic Qualification Certificate.
- ii. Date of Birth Certificate.
- iii. Resident Certificate.
- iv. Health Certificate from the concerned Chief Medical Officer of the District.
- v. Dependent Certificate.
- vi. All other relevant documents as required under SRO-43 of 1994.

**The appointment shall further be subject to the following conditions:**

- a) That the appointee shall submit an undertaking in an Affidavit to the effect that if, on verification, the genuineness of any certificate from the concerned issuing authority is found fake/forged, the claim of the appointee for appointment as Constable in Ladakh Police shall be deemed to have been cancelled ab-initio and the legal action as warranted under rules shall be initiated against the appointee.
- b) Expenditure towards the pay and allowances shall be debited against the head of "Salaries" from the Budget Head associated with the respective place of posting upon deployment in the sub-ordinate offices of the Department.
- c) The proposed post for the appointment of the applicant has not been referred to any recruiting agency/board.


- d) Head of Police, UT of Ladakh shall verify to his satisfaction that the deceased was substantially employed in the J&K Government/UT Administration by the Competent Authority.
- e) If the appointee fails to join within a period of 21 (twenty-one) days from the date of issuance of this order, she shall forego her right to appointment which shall be deemed to have been cancelled ab initio, without any further notice.
