As recommended by the Staff Selection Commission, against the post category No:- NW23322, vide SSC's F.No.: S/30020/6/2022-Selection Post_NWR (CF 3467), dated: 08.05.2024 Selection Ladakh Post and consequent upon the clearance of the medical board vide above-referred reference, the sanction is hereby accorded to the provisional appointment of the candidates as per 'Annexure-A' to this Order, against the Post of the **Junior Statistical Assistant** (UT Cadre) in the Ladakh Economics & Statistics (Subordinate) Service in the **pay Level-5 (29200-92300)** with immediate effect.

Consequent upon the above, the appointee shall report, to the Planning Development & Monitoring Department within a period of **twenty-one (21) days** from the date of issuance of this order.

If the candidate fails to join within the stipulated time, he/she shall forego his/her right to appointment, and the same shall be deemed to have been cancelled without further notice.

The appointee shall be allowed to join only on the production of the following certificated (in original) to be verified subsequently by the competent authority:-

- ii. Date of Birth Certificate.
- iii. Residence Certificate issued by the Competent Authority.
- iv. Category Certificate.

The appointment of the above candidates shall further be subject to the following conditions that: -

- i. The appointee shall give an undertaking in the shape of an Affidavit to the effect that if, on verification, his/her Qualification/ Date of Birth/ Reserved Category Certificates/ any other certificate from the concerned issuing

- authorities is found fake / forged or the institution / Course itself is found to not recognized, his appointment as '**Junior Statistical Assistant**' in the Ladakh Economics and Statistics (Subordinate) service shall be deemed to have cancelled ab-initio without any further notice and the legal action as warranted under rules shall be initiated against him.
- ii. The Salary of the appointee shall be drawn and disbursed to them after receipt of the verification report from the competent verifying agency, viz, CID.
 - iii. The appointee shall be on probation for a period of two years.
 - iv. The seniority of the appointee in the Ladakh Economics & Statistics (Subordinate) service shall be determined as per the select list rank issued by the Staff Selection Commission.
 - v. The appointment of the candidate shall be subject to the outcome of writ petition (S), if any, pending before a competent Court of Law, which may not be presently within the knowledge of the Department.
