Consequent upon the selection made by the Staff Selection Commission (referred above) and allocation of Department made by the General Administration Department Ladakh vide Order No: 219-LA(GAD) of 2024 dated: 06.05.2024 to the provisionally selected candidates for the post of Junior Assistant and in response to the acceptance of Offer of Appointment issued Vide Office Memorandum No: Secy(FCS&CA)/27/Gen/2024/UTL/1091-95 dated: 04.06.2024, Sh. Amjeet Hussain S/o Mohd Hussain R/o Chulichan, Batalik, Kargil-Ladakh is hereby appointed to the post of Junior Assistant in Level 4 of Pay Matrix (Rs. 25500-81100) and other allowance as admissible under the rules, with immediate effect.

1. The appointee shall be on probation for a period of two year with effect from the date of their joining the post. During the period of probation, the appointee will be liable to be discharged from service at any time without any notice, If

(a). On the basis of his/her performance or conduct, he/she is considered unsuitable for further retention in service.

- (b). he/she is otherwise found ineligible for unsuitable to be retained in the service.
- 2. The appointment is subject to the verification of character and antecedents' verification of the certificates for reserved category and verification of certificates/marksheets relating to the educational qualification and such essential requirements as prescribed in Ladakh Food Civil Supplies & Consumer Affairs (Subordinate) Service Rule, 2021.
- 3. The above appointee has been declared medically fit by the prescribed Medical Authority vide letter No.CMO-K/DMB/2024/1559-60Dated: 01/07/2024.
- 4. Other conditions of service will be governed by the relevant rules and orders in force from time to time.
- 5. It is further ordered that the appointee shall report to Director, Food Civil Supplies and Consumer Affairs, UT Ladakh for joining within a period of one month from this issuance, failing which his/her appointment shall be deemed to have been cancelled ab-initio.
- 6. The appointment of the candidate shall be subject to the outcome of writ petition, if any, pending before a competent Court of Law, which may not be presently within the knowledge of the Department.
