- b. JERC reserves the right to not to fill up the above positions or to cancel/amend the entire/part of this advertisement/ recruitment process/condition of recruitment and the candidature is

liable to be rejected at any stage of recruitment process at any given time, without assigning

any reasons, whatsoever.

c. The age of the candidate shall not exceed 56 years as on the date of the advertisement of the vacancy. The age limit of the candidates will be calculated on the basis of the Matriculation Certificate/Date of Birth certificate issued by a recognized Authority/Board/Council. No other document shall be accepted in lieu thereof for the purpose. d. Candidates may also note that for any lapse/shortfall in submission of application due to any

reasons, this Commission will not be responsible. No TA/DA will be admissible for attending the interview.

#### Additional terms and conditions are as under:

The appointment on deputation on foreign services terms basis shall be made initially for a period of three years. Extension beyond this period would be considered in consultation with the Central Government subject to satisfactory performance appraisal every year.

b. The eligibility of such candidates who are working in PSUs or other Govt. Organizations where Industrial/ Variable Dearness Allowance pattern is applicable, shall be determined by equating their IDANDA pattern pay scale with the requisite CDA pattern pay scales as being normally done. The candidate is working in the Autonomous body/Govt. undertaking, PSU the correspondent pay scale as mentioned in the advertisement should be mentioned.
