Whereas, the Tentative Seniority list of the Gazetted Officers (UT Cadre) in the Agriculture Department, UT of Ladakh, as of 31-03-2024, was notified vide Circular F. No. A-23/3/2024-AC/HC AND FC SEC Dated: 23-04-2024, for the information of all the Officers of the Department and inviting objections, if any, against their placements within a period of 15 days from the date of issuance of the said circular.

However, no objections were received from the Officers within the stipulated time. Despite this, the final seniority list could not be notified due to the imposition of the Model Code of Conduct. Given the significant time lapse since the issuance of the tentative seniority list, it has been decided that the seniority list will be put in the public domain again for 7 days to receive objections/comments from the officers, if any before submitting the same to the Competent Authority for approval.

Therefore, a tentative seniority list of Gazetted Officers (UT Cadre) in the Agriculture Department, UT of Ladakh, as of 30-06-2024 is hereby notified and attached as **Annexure 'A'** to this circular.

Accordingly, officers in the Agriculture Department, UT of Ladakh, are hereby given the opportunity to make representations to the Administrative Department. If any officer is aggrieved by their assigned position or not included in the tentative seniority list, they should submit their representation with supporting documents **within 07 days** from the date of issuance of this circular.

In case, an officer chooses not to file any objection, it shall be construed that there is nothing objectionable against the seniority position. The final seniority list of officers in the Agriculture Department, UT of Ladakh, shall be issued accordingly with the approval of the competent authority.


