 - (a) on the basis of his/her performance or conduct, he/she is considered unsuitable for further retention in service.

or

- (b) he/she is otherwise found ineligible or unsuitable to be retained in the service.
- 2. The above appointees have been declared medically fit by the Prescribed Medical Authority.
- 3. The appointment is subject to the verification of character and antecedents; verification of the certificates of reserved category; and verification of certificates/marksheets

- relating to the educational qualification and such essential requirements as prescribed in Ladakh Animal Husbandry (Subordinate) Service Recruitment Rules, 2022.
- 4. Other conditions of service will be governed by the relevant rules and orders in force from time to time.
