Subject: Cancellation of Appointment Order against the post of 'Driver Grade-II', in respect of Mr. Stanzin Lungstob, in General Administration Department of the Administration of Union territory of Ladakh, under UT Cadre in Pay Structure (₹ 19900 - 63200) Level-2 of pay matrix.

Whereas, Staff Selection Commission (SSC) vide the above referred Notice dated 05.02.2024, *inter alia* amongst others recommended the name of Mr. Stanzin Lungstob, S/o Sh. Phuntsog Angchuk, R/o Phey, Leh for appointment as Driver Grade-II in the Administration of UT of Ladakh in the Pay Structure (₹ 19900-63200) Level-2 of pay matrix.

Whereas, in pursuance of the above-referred Provisional Select List, and in accordance with *para 18.22* of the Advertisement Notification Selection Post/Ladakh/2022, the General Administration Department (GAD), *vide* Memorandum issued under file No: A/12/2/2021/O/o Un Secy GAD dated: 23.02.2024, sought the preference of Departments for the post of Driver Grade-II from the provisionally selected candidates.

Whereas, based on the preference given by the candidates, considering their merit in the select list; GAD, *vide* Order No: 138 LA(GAD) of 2024 dated: 15.03.2024, *inter alia* others, the said Mr. Stanzin Lungstob was allocated to GAD.

Whereas, accordingly GAD under File No. A - 12 / 17 / 2024 - GAD SEC dated:16.03.2024, issued an "Offer of Appointment" in favour of the said Mr. Stanzin Lungstob as Driver Grade-II in the Pay Structure (₹ 19900-63200) Level-2 of the pay matrix, wherein a period of thirty (30) days was given to him to accept the offer. Accordingly, he accepted the offer of appointment on 12.04.2024.

Whereas, an Appointment Order was issued in favour of the said Mr. Stanzin Lungstob vide Order No: 199-LA(GAD) of 2024 dated:18.04.2024. On 15.05.2024 Mr. Stanzin Lungstob


approached GAD with a representation seeking an extension in the time limit to join the post of Driver Grade-II.

Whereas, considering his representation and in light of DoPT OM issued under file No 35015/2/93-Estt(D) dated 09.08.1995; GAD vide Order No. 229-LA (GAD) of 2024 dated 21.05.2024, had extended the joining time for one month w.e.f. the date of notification of above order. The said *Mr. Stanzin Lungstob*, did not join the said post of Driver Grade - II

Whereas, on 16.08.2024 *Mr. Stanzin Lungstob* submitted an undertaking declaring therein his unwillingness to join for the post of Driver Grade-II in GAD.

Now, therefore, considering the above, the Appointment Order issued in favour of *Mr. Stanzin Lungstob* as Driver Grade-II in GAD is hereby deemed to have been cancelled *ab-initio*.
