- 1. The approval is subject to the fulfillment of provisions laid down in the Ladakh Paramedical Council.
- 2. No capitation fee will be charged by the Institute.
- 3. The permission shall be subject to any policy on the subject, which the Government may sanction in future for regulation of these Institutes.
- 4. Eligibility of candidates for admission to the above Courses shall be made on merit basis as per the provisions laid down by the Government from time to time.

- 5. The Committee shall conduct inspection of the institute, periodically to monitor and assess the adequacy of infrastructure in relation to the number of trainees.
- 6. An amount of Rs 5000/- per trainee per session be charged by the institution on accounts of providing hospital facility and the amount so received be utilized for Hospital Development fund of the Hospital to which the institute is attached.
- 7. For any lapse on the part of student/students resulting in loss/damage to equipment/chemical etc. the institute shall be responsible for it. An undertaking to this effect be executed by the management of the institution with the Medical Superintendent of the Hospital.
- 8. The Ladakh Paramedical Council shall conduct examination of the trainces on the same pattern as in case of trainees of GNM/AMT Schools in the UT Ladakh.
