The Appointee shall report to the Director, Rural Development Department, UT Ladakh, within the period of 21 days from the date of issuance of this Order and shall be allowed to join only on the production of the following documents/certificates (in original) to be verified subsequently:

- i. Academic Qualification Certificate.
- ii. Date of Birth Certificate.
- iii. Resident Certificate.
- iv. Dependent Certificate.
- v. Health Certificate from the concerned Chief Medical Officer of the District.
- vi. All other relevant documents as required under SRO-43 of 1994.

The appointment of the appointee, shall further be subject to the following conditions:

- a. That the appointee shall submit an undertaking in an Affidavit to the effect that if, on verification the genuineness of any certificate from the concerned issuing authority is found/forged, the claim of the appointee to the appointment as Orderly in Rural Development Department, UT Ladakh shall be deemed to have been cancelled ab-initio and legal action as warranted under shall be initiated against the appointee.
- b. Expenditure towards the pay and allowances shall be debited against the head of Salaries from the Budget Head associated with the respective place of posting upon deployment in the subordinate offices of the Department.
- c. The proposed post earmarked for appointment of the applicant has not been referred to any recruitment agency/board.
- d. The appointee shall be initially on probation for a period of two years.
- e. The Director, Rural Development Department, UT Ladakh shall verify to his satisfaction that the deceased was substantially employed in the UT Administration by the Competent Authority.

f. If the Appointee fails to join within a period of 21 days from the issuance of this order, he shall forego to his right to his appointment which shall be deemed to have been cancelled ab-initio without any further notice.
