

Subject: Filling up the post of UT Commissioner for Persons with Disabilities, UT-Ladakh.

In adherence to sub-section (1) section 79 of the Rights of Persons with Disabilities (PwDs) Act 2016 and Rule 26 of the Ladakh Rights of Persons with Disabilities Rules, 2024 issued vide S.O. 8. dated 05.02.2024, applications are being invited from eligible interested individuals to the post of Commissioner for Persons with Disabilities.

1. **Name of the Post:** Commissioner for Persons with Disabilities.
2. **Number of Posts:** 01 (One)
3. **Salary and allowances:** 37400-67000 +GP 10000- (pre-revised)
 - a) The salary and allowances of the UT Commissioner shall be the salary and allowances as admissible to a Secretary to the Administration of UT Ladakh.
 - b) Where a UT Commissioner, being a retired government servant or a retired employee of any institution or autonomous body funded by the Central or State Government, is in receipt of pension in respect of such previous service, the salary admissible to the UT Commissioner under these rules shall be reduced by the amount of the pension, and if in lieu of a portion of the pension, the commuted value thereof has been received, by the amount of such commuted portion of the pension.
4. **Eligibility Criteria:**
 - i. The candidate should have special knowledge or practical experience in respect to matters relating to rehabilitation of persons with disabilities;
 - ii. has not attained the age of sixty years of the 1st of January of the year in which the last date for receipt of applications, as specified in the advertisement inviting for the appointment of the State Commissioner, occurs;
 - iii. if in service under the Central Government or the State Government, shall seek retirement from such service before being appointed to the post;
 - iv. and possesses the following educational qualifications and experience, namely: -

- a. **Educational qualifications:** -
- i. Essential: Graduate from a recognized University
 - ii. Desirable: Recognized Degree or Diploma in Social Work or Law or Management or Human Rights or Rehabilitation or education of disabled persons.
- b. **Experience:** At least twenty years of experience in a Group A level or equivalent post: -
- i. In central or state Government or
 - ii. Public sector undertakings or Semi Government or Autonomous Bodies dealing with Disability related matters or social sector or
 - iii. Works in the capacity of a senior level functionary in a registered state or national or international level voluntary organization working in the field of Disability or Socio Development:


Provided that out of the total twenty years' experience mentioned in this subclause, at least ten years of experience in the recent past had been in the field of empowerment of persons with Disabilities,

5. Term of the UT Commissioner:

- a) The State Commissioner shall be appointed on full-time basis for a period of three years from the date of assumption of office, or till the attainment of the age of sixty-five years, whichever is earlier.
- b) A person may serve as UT Commissioner for a maximum of two terms, subject to the upper age limit of sixty-five years.

6. Other terms and conditions of service of the UT Commissioner: The other terms and conditions of service of UT Commissioner shall be such as specified in the Ladakh Rights of Persons with Disabilities Rules, 2024.

7. Interested eligible candidates may apply in the prescribed proforma (annexure attached) along with supporting documents.
