## The appointment shall be subject to the following conditions;

- 1. The appointee shall be on probation for a period of two years with effect from the date she joins the post. During the period of probation, the appointee will be liable to be discharged from service at any time without any notice, if:
  - a) On the basis of performance or conduct, He/she is considered unsuitable for further retention in service, or
  - b) He/She is otherwise found ineligible or unsuitable to be retained in the service.
- 2. The above appointee has been declared medically fit by the Prescribed Medical Authority.

3. This appointment is subject to the verification of character and antecedents; verification of the certificates of reserved category; and verification of certificates / marksheets relating to the educational qualification and such essential requirements as prescribed in the Ladakh Health and Medical Education Department Subordinate Service Recruitment Rules, 2021.

It is further ordered that;

1. The services of the above candidate appointed as Library Assistant is placed at the disposal of the Chief Medical Officer, Kargil for further deployment in the Sub-ordinate Offices of the Health and Medical Education Department, Kargil.

- 2. The appointee shall report to the Chief Medical Officer, Kargil for joining within a period of **one (01) month**, from the date of issuance of this Order, failing which His/her appointment shall be deemed to have been cancelled ab-initio.
- 3. The expenditure towards pay and allowances shall be debited against the head of "Salaries" from the Budget Head associated with her respective place of posting upon her deployment in the Sub-ordinate Office of Health and Medical Education Department, Kargil.
