- **3.** This appointment is subject to the verification of character and antecedents; verification of the certificates of reserved category; and verification of certificates / marksheets relating to the educational qualification and such essential requirements as prescribed in the Ladakh Forensic (Subordinate) Service Recruitment Rules, 2022.
- **4.** Other terms and conditions will be governed by the relevant Central Service Rules and Orders in force from time to time.

 The Services of the above appointee are placed at the disposal of Deputy Director Forensic Science Laboratory, UT of Ladakh for further deployment.

- The appointee shall report to the Deputy Director Forensic Science Laboratory, UT of Ladakh for joining within a period of one (01) month from the date of issuance of this Order, failing which his appointment shall be deemed to have been cancelled ab-initio.
- 3. The expenditure towards his pay and allowances shall be debited against the head of "Salaries" from the Budget Head associated with the respective place of posting upon his deployment in the sub-ordinate office(s) of the Department.
