Whereas, vide the above referred notification, dated: 24.06.2024, the Ladakh Autonomous Hill Development-Kargil Subordinate Service Recruitment Board (LAHD-KSSRB) has issued a selection list of the 02 candidates against the post of Junior Assistant/Tabulator Cum Operator) in Rural Development Department, UT Ladakh, in level 4 of pay matrix (Rs.25500-81100).

Whereas, Rural Development Department, Ladakh vide Memorandum No.Adm.Secy/RDD (UTL)/2024/355-360, dated: 30.07.2024 has issued Offer of Appointment to the provisionally selected 02 candidates against the post of Junior Assistant/Tabulator Cum Operator in Rural Development Department, UT Ladakh.
