The appointment shall be subject to the following conditions;

1. The appointees shall be on probation for a period of two years with effect from the date he /she join the post. During the period of probation, the appointee will be liable to be discharged from service at any time without any notice, if:
 - a) On the basis of their performance or conduct, he / she is considered unsuitable for further retention in service, or

b) *He / She is otherwise found ineligible or unsuitable to be retained in the service.*

2. The above appointees have been declared medically fit by the Prescribed Medical Authority.
3. This appointment is subject to the verification of character and antecedents; verification of the certificates of reserved category; and verification of certificates / marksheets relating to the educational qualification and such essential requirements as prescribed under the Union Territory of Ladakh School Education Department (Subordinate) Service Recruitment Rules, 2021.
4. Other terms & conditions will be governed by the relevant Central Civil Service Rules & Orders in force from time to time.

It is further ordered that;

1. The services of the above candidates appointed as **Teachers** are placed at the disposal of Chief Education Officer, Leh for further deployment.
2. The appointees shall report to the Office of Chief Education Officer, Leh for joining within a period of one (01) month, from the date of issuance of this order, failing which his / her appointment shall be deemed to have been cancelled ab-initio without any further notice.
3. The expenditure towards pay & allowances shall be debited against the head of "Salaries" from the Budget Head associated with the respective place of posting upon her deployment in the respective office.


