The appointment shall be subject to the following conditions;

1. The appointees shall be on probation for a period of two years with effect from the date he / she joins the post. During the period of probation, the appointees will be liable to be discharged from service at any time without any notice, if:
 - a) *On the basis of his / her performance or conduct, he / she is considered unsuitable for further retention in service, or*
 - b) *He / She is otherwise found ineligible or unsuitable to be retained in the service.*
2. The above appointees have been declared medically fit by the Prescribed Medical Authority.
3. This appointment is subject to the verification of character and antecedents; verification of the certificates of reserved category; and verification of certificates / marksheets relating to the educational qualification and such essential requirements as prescribed in the Union Territory of Ladakh Industries & Commerce (Subordinate) Service Recruitment Rules, 2022.
4. Other terms & conditions will be governed by the relevant Central Civil Service Rules & Orders in force from time to time.

It is further ordered that;

1. The services of the above candidates appointed as Mineral Guard/Mining Helper/Helper are placed at the disposal of the Director Industries & Commerce Department, UT Ladakh for further deployment.
2. The appointees shall report to the office of Director Industries & Commerce UT Ladakh for joining within a period of one (01) month, from the date of issuance of this order, failing which his/her appointment shall be deemed to have been cancelled ab-initio without any further notice.


