The appointment of the appointee shall further be subject to the following conditions:

(a) That the appointee shall give an undertaking in the shape of an Affidavit to the effect that if, on verification, the genuineness of any certificate from the concerned issuing authority is found fake/ forged, the claim of the appointee for appointment as Follower in Ladakh Police shall be deemed to have been cancelled ab-initio and the legal action as warranted under rules shall be initiated against her.

(b) Expenditure towards the pay and allowances shall be debited against the head of "Salaries" from the Budget Head associated with the respective place of posting upon deployment in the sub-ordinate offices of the Department.

(c) The proposed post for appointment of the applicant has not been referred to any recruiting

agency/board.

(d) Director General (Head) of Police, UT of Ladakh shall verify to his satisfaction that the deceased was substantially employed in the J&K Government/ UT Administration by the Competent Authority.

(e) If the appointee fails to join within a period of 21 (twenty-one) days from the date of issuance of this order, she shall forego her right to appointment which shall be deemed to have been

cancelled ab-initio, without any further notice.
