Whereas the Staff Selection Commission (SSC), vide the above-referred notice, declared results (by operating the Reserve List) for the post of Orderly, Post Category NW20822, and recommended 32 candidates for appointment as Orderly.

2. And whereas, in pursuance of the aforementioned result and in accordance with paragraph 18.22 of the Advertisement Notification No. Selection Posts / Ladakh / 2022, the General Administration Department called the selected candidates, vide notice dated 03.10.2024, for a Counselling Session to allocate Departments based on merit and preference. The Counselling Session was held on 10.10.2024. During the session, 06 candidates attended online, 17 candidates attended offline, and 9 candidates did not attend, submitting undertakings expressing their unwillingness to join the post.

3. And whereas, the preferences of the candidates who attended the counselling session were recorded. Accordingly, based on the candidates' preferences, their merit in the Select List, and the availability of vacancies in the preferred Departments, the allocation of Department for each candidate was determined.

4. Now, therefore, in view of the above, the following is hereby ordered:

- a. Allocation of Departments to the candidates shall be as per the *Annexure* to this Order.
- b. The candidates are advised to report to the Administrative Secretary of the Department concerned in the UT Secretariat, Leh within one week from the date of issuance of this Order.
- c. The Department concerned shall process the appointments of the candidates as per the instructions of the General Administration Department, as outlined in the Office Memorandum dated 12.10.2023 issued under File No. A-12/2/2021-O/o Un Secy-GAD.
