Notification Ladakh, the 23rd of October, 2024

S.O. 113_In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, read with the Government of India Ministry of Home Affairs, New Delhi Notification No. S.O. 5088(E), dated 1st November, 2022, the Lieutenant Governor (Administrator) of Union territory of Ladakh, hereby makes the following rules regulating the method of recruitment to the post of **District Level Subject Matter Specialist Pomology/Entomology** in the Ladakh Horticulture Department, namely:

1. Short title and commencement:

- (i) These rules may be called the Ladakh Administration, **District Level Subject**Matter Specialist Pomology/Entomology in the Ladakh Horticulture Department Rules, 2024.
- (ii) These rules shall come into force from the date of their publication in the official Gazette.

2. Number of posts, classification and Level in the Pay Matrix:

The number of said post, its classification and level in the pay Matrix attached hereto shall be as in column (2), (3) & (4) of the Schedule annexed hereto.

. Method of recruitment, age limit, other qualifications:

The method of recruitment to the said post, age limit, qualifications and other matters relating to said posts shall be as specified in columns 5 to 13 of the Schedule annexed hereto.

4. Provision for Resident Criteria for appointment by direct recruitment:

The eligibility for appointment will be subject to residency requirements prescribed in any Act, Rule, Regulation or Order in force in the Union Territory of Ladakh.

5. Disqualification:

No person,

J.

1. who has entered into or contracted a marriage with a person having a spouse living;

OR

1. who having a spouse living, has entered into or contracted a marriage with any person (s) shall be eligible for appointment to the said post;

Provided that the Lieutenant Governor (Administrator) of Ladakh may, if satisfied that such marriage is permissible under the personal law, applicable to such person(s) and the other party to the marriage or there are other grounds for so doing, exempt any person from the operation of these rules.

6. Power to relax:

Where the Lieutenant Governor (Administrator) Union Territory of Ladakh is of the opinion that, it is necessary or expedient to do so, he may, by order for reasons to be recorded in writing and in consultation with UPSC, relax any of the provisions of these rules with respect to any class or category of persons.

7. Savings:

Nothing in these rules shall affect reservations, relaxation in age limit and other concessions required to be provided for the Scheduled Castes, Scheduled Tribes, and the other special categories in accordance with the Rules, Instructions, or Orders issued by the **Administration of Union Territory of Ladakh.**

Deputation (Including Short Term Contract):

Central Government / State Governments / Union Territory Administrations/ Public Sector Undertakings / Universities/ Recognized Research Institutions/ Autonomous Bodies / Statutory Organization:

- a) (i) Holding analogous post on regular basis in the parent cadre / Department; Or
- (ii) with 2 Years of regular service in the post in the level-8 in the pay matrix or equivalent in the parent cadre or department; OR
- (iii) with 3 years of regular service in the post in the level -7 in the pay matrix or equivalent in the parent cadre/ Department; and
- (B) Possessing the following educational qualifications and experience:
- (i) Postgraduate degree in Pomology or Entomology from a recognized University or Institute.
- (ii) At least two years experience in the field of Pomology or Entomology.

Standard Note:

juniors who have completed qualifying/eligibility service are being considered for promotion, their senior would also be considered provided they are not short of the requisite qualifying / eligibility service by more than half of such qualifying /eligibility service or 2 years, whichever is less and have successfully completed their probation period for promotion to the next higher grade along with their iuniors have already completed who such qualifying/eligibility service.

The departmental officers in the feeder category who are in the direct line of promotion shall not be eligible for consideration for appointment on deputation. Similarly, the deputationists shall not be eligible for consideration for appointment by promotion.

The period of deputation including the period of deputation in another ex-cadre post held immediately
