Whereas , in response to that the Chief Medical Officer, Leh and Kargil has has submitted the objections of Dr. Syed Mustansir-Ul-Hasnaain, and Muddasir Ishrat Amin, Dental Surgeons respectively and accordingly same were examined and found veiled.
