Subject: Allocation of Departments to the provisionally selected candidates, for the post of Orderly / Chowkidar / Class IV (Post Category NW 22323), advertised by the Staff Selection Commission (SSC), vide Advertisement No. Selection Posts / Ladakh / 2023.

Whereas, in pursuance of the above-referred Provisional Select List for the post of Orderly / Chowkidar / Class IV, issued by the Staff Selection Commission, and in accordance with *para 19.21* of the Advertisement Notification mentioned in the subject, the General Administration Department, *vide* the above-referred Memorandum, sought the preference of Departments for the post of Orderly / Chowkidar / Class IV from the provisionally selected candidates.;

And whereas, out of the 39 provisionally selected candidates recommended by SSC *vide* the above-mentioned notice, 31 candidates have submitted their preferences of Departments in response to the Memorandum under reference, and 08 recommended candidates have responded that they are not willing to join the post.;

And whereas, accordingly, the allocation of Departments to the 31 provisionally selected candidates, who have submitted their preferences, has been determined based on the preferences of departments submitted by the candidates, their merit in the Select List, the category against which they are selected, and the availability of vacancies in the preferred department for the category/reserved category under which they have been selected.;

Now, therefore, in light of the above, it is hereby ordered, that:

- (a) The allocation of Departments to the candidates shall be as per the **Annexure** to this Order.
- (b) The candidates are advised to report to the Administrative Secretary of the Department concerned in the UT Secretariat within one week of the issuance of this Order.
- (c) The Department concerned shall process the appointment of the candidates as per the instructions of the General Administration Department as contained in Office Memorandum dated 12.10.2023 issued under File No. A-12/2/2021-O/o Un Secy-GAD.
