Whereas, vide Govt. Order No.460-PW(R&B) of 2019 dated:22.10.2019, final seniority list of Junior Engineer (Civil) of Public Works Department was issued by the UT of J&K, which among others, also included the Junior Engineers (Civil) of the UT of Ladakh;

Whereas, vide Govt. Order No.266-PW(R&B) of 2022 dated:06.08.2022, Govt Order No.338-PW(R&B) of 2022 dated: 22.09.2022 and G. Order No.11-PW(R&B) of 2023 dated: 04.01.2023, the UT of J&K regularized the I/c Assistant Engineer (Civil) as Assistant Engineer (Civil), which among others also included the I/c Assistant Engineers (Civil) belonging to the UT of Ladakh and who were placed in In-charge capacity by the erstwhile State of J&K before the date of apportionment i.e 15.11.2021.

Whereas, in terms of J&K Reorganization Act, 2019, vide Order No.1212-JK(GAD) of 2021 dated:15.11.2021, read with subsequent Orders in the matter issued from time to time, the UT of J&K issued Orders of apportionment of employees between the two Union territories and the employees belonging to Ladakh, who have opted UT of Ladakh, was apportioned to the UT of Ladakh, which among others also included the Assistant Engineers (Civil) of Public Works (R&B) Department, UT of Ladakh;

Whereas, subsequent to the apportionment of manpower between the two Union territories, the UT of J&K has issued tentative seniority list of Assistant
