5. *The appointees shall report to the Directorate of Accounts & Treasuries, Finance Department, Council Secretariat (Wildlife Complex), UT Ladakh for joining within a period of one (01) month, from the date of issuance of this Order, failing which, his/her appointment shall be deemed to have been canceled ab-initio.*
