1. The appointees shall report to the Department of Law and Justice within a period of 21 days from the date of issuance of this order and such candidates who fail to join within the stipulated time, shall forego his/her right to appointment and the same shall be deemed to have been cancelled ab-initio without any further notice.
2. The service conditions of the above-appointed Orderlies shall be governed by the Ladakh Legal (*Subordinate*) Service Recruitment Rules, 2021.
3. If any adverse report about his/her character and antecedents is received from the Director General of Police, Criminal Investigation Department, Ladakh;

or

Any qualification certificate / reserved category certificate / experience certificate (*wherever applicable*) is found false or fake on verification from the concerned issuing authorities;

In such cases, the appointed candidates shall have no right to claim his/her appointment and his/her appointment shall be deemed to have been cancelled ab initio.

4. The salary of the appointees shall not be drawn and disbursed to them unless a satisfactory report/genuineness of the certificates in respect of the above para (3) is received.
5. The appointees shall be on probation for a period of two years. The conditions of probation as prescribed in the Union Territory of Ladakh Legal (*Subordinate*) Service Recruitment Rules, 2021 and other rules / instructions issued in this regard by the Central Government/Administration of Union territory of Ladakh shall be applicable to the appointees.
6. The appointed candidates shall have to serve anywhere within the territorial/Administrative jurisdiction of the Union territory of Ladakh


