And whereas, the allocation of Departments to the *06* provisionally selected candidates, who have submitted their preferences, has been determined based on the preferences of Departments submitted by the candidates, their merit in the Select List, the category against which they are selected, and the availability of vacancies in the preferred Department for the category / reserved category under which they have been selected.

Now, therefore, in light of the above, it is hereby ordered that:

- Allocation of Departments to the candidates shall be as per Annexure to this Order.
- (ii) The candidates are advised to report to the Administrative Secretary of the Department concerned in the UT Secretariat within one week from the date of issuance of this Order.

(iii) The Department concerned shall process the appointment of the candidates as per the instructions of General Administration Department as contained in *Office Memorandum dated 12.10.2023* issued under *File No. A-12/2/2021-O/o Un Secy-GAD*.
