*The appointment shall be subject to the following conditions, that;*

1. *The appointees shall be on probation for a period of two years with effect from the date of his / her joining to the post. During the period of probation, the appointees will be liable to be discharged from service at any time without any notice, if:
  - a) *On the basis of his / her performance or conduct, He/she is considered unsuitable for further retention in service, or*
  - b) *He / She is otherwise found ineligible or unsuitable to be retained in the service.**
2. *The above appointees have been declared medically fit by the Prescribed Medical Authority.*
3. *This appointment is subject to the verification of character and antecedents; verification of the certificates of reserved category; and verification of certificates / marksheets relating to the educational qualification and such essential requirements as prescribed in the Ladakh Public Health Engineering/Irrigation & Flood Control Subordinate Service Recruitment Rules, 2022.*
