VACANCY CIRCULAR

The constitution of Joint Electricity Regulatory Commission (JERC) for UT of J&K and UT of Ladakh has been notified by the Government of India under the provisions of the Electricity Act, 2003, vide notification S.O.1984(E) dated 18.6.2020. Office of the Commission is located at Jammu. The Commission consists of a Chairperson and one Member. **The post of Chairperson in the said JERC will fall vacant on 25.05.2025.**

2. Appointment to the post of Chairperson, JERC for UTs of J&K and Ladakh shall be governed by the relevant provisions of the Electricity Act, 2003 and the Joint Electricity Regulatory Commission for Union Territories except Delhi (Salary, Allowances and other Conditions of Service of Chairperson and Member) Rules, 2007 and as amended from time to time. Chairperson of JERC of UTs of J&K and Ladakh shall be entitled to receive pay as admissible to the Secretary to the Government of India.

3. As mandated under section 84 of the Act, the Chairperson of the JERC for UTs of J&K and Ladakh shall be a person of ability, integrity and standing, with adequate knowledge of, and demonstrated capacity in dealing with, problems relating to engineering, finance, commerce, economics, or management.

4. Chairperson of JERC for UT of J&K and UT of Ladakh shall hold office for a term of five years from the date on which he/ she joins office or attains the age of sixty-five years, whichever is earlier. The candidate will have to give a declaration that he/she does not have any financial or other interest, which is likely to affect prejudicial his/her function as Chairperson of the above JERC.

5.
