Any qualification certificate/reserved category certificate/experience certificate (wherever applicable) if found false or fake on verification from the concerned issuing authorities;

*In such cases, the appointed candidates shall have no right to claim his/her appointment and his/her appointment shall be deemed to have been cancelled ab initio.*

4. The salary of the appointees shall not be drawn and disbursed to them unless a




- satisfactory report /genuineness of the certificates in respect of the Para(3) is received.
5. The appointees shall be on a probation for a period of 2 years. The conditions of the probation as prescribed in the Union Territory of Ladakh Hospitality and Protocol (*Subordinate*) Service Recruitment Rules, 2021 and other Rules/ instructions issued in this regard by the Central Government/ Administration of Union Territory of Ladakh shall be applicable to the appointees.
