NOTICE

In continuation to the Notice issued under Endorsement No. TRM/STP-442/1175-82, dated: 05/11/2024 from the office of Assistant Director, Tourism, Leh. It is for the information of all hotel/guest house owners that the Department of Tourism, Union Territory of Ladakh, has framed and notified the "**Ladakh STP Policy 2024**" vide Notification No: Secy (Trm)/STP/2024/(224)/1729-42, dated 17/09/2024. The STP Incentive Scheme 2024 aims to promote the installation and effective operation of decentralized STPs in hotels/guest houses with 1-19 rooms across the UT of Ladakh.

All eligible hotels and guest houses operating in Leh district, who intend to install a decentralized Sewerage Treatment Plant (STP), can apply for the incentive under the scheme using the prescribed application form. The application form and further details can be obtained from the office of the Assistant Director (Tourism), Leh, from **5th December 2024 to 20th December 2024** on all working days during office hours. Completed application forms, along with the relevant documents, must reach the office of the Assistant Director (Tourism), Leh, on or before **20th December 2024**.

Eligible hotels and guest houses operating in the Union Territory of Ladakh must fulfill the following minimum criteria to avail the incentive under the STP Incentive Scheme 2024:

1. New or existing hotels and guest houses in the Union Territory of Ladakh with a room count of 1-19.
2. Registered with the Department of Tourism, UT Ladakh.
3. Shall have the necessary permissions and NOCs for operating the hotel/guest house in the Union Territory of Ladakh.

Note: It is also expected that eligible hotels and guest houses applying for the incentive under the STP Incentive Scheme 2024 shall have a fixed meter on the borewell at the establishment and sufficient ground area for STP installation.

The Incentive shall reimburse the cost of the equipment based on the room count and the STP Capacity as per below:

S. No	Room Count	STP Capacity	Incentive
1	10-19 Rooms	10 KLD	75% of the cost of the equipment, subject to a limit of Rs. 5,00,000/- (Rupees Five Lakh Only), whichever is less
2	1-9 Rooms	5 KLD	75% of the cost of the equipment, subject to a limit of Rs. 3,00,000/- (Rupees Three Lakh Only), whichever is less

Note: To support women entrepreneurship in the Union Territory of Ladakh, the maximum quantum of incentive shall be raised by an additional amount of 10% across each category for a new hotel or guesthouse which is owned by a woman.
