Subject: Provisional Common Seniority List of Section Officers of Heads of Departments – UT of Ladakh

#### **OFFICE MEMORANDUM**

Whereas, the Government of Jammu & Kashmir, vide Order No. 1212-JK(GAD) of 2021 dated 15.11.2021, and subsequent orders issued from time to time, apportioned employees between the two Union territories (UTs). Employees belonging to Ladakh who opted for the UT of Ladakh were accordingly allocated, including Section Officers serving in various Heads of Departments.

Whereas, as per Jammu and Kashmir General Administration Department (GAD) Circular No. 09-JK(GAD) of 2022 dated 08.03.2022, it has been stated that employees apportioned to the UT of Ladakh under Government Order No. 1212-JK(GAD) of 2021 shall be excluded from the seniority/eligibility lists of the UT of Jammu & Kashmir. Consequently, these employees shall not be considered for promotions in the UT of Jammu & Kashmir with effect from 15.11.2021.

Whereas, in the erstwhile state of Jammu & Kashmir, the seniority list of Section Officers of the Heads of Departments was maintained by the J&K GAD.

**Whereas,** in light of the above, the General Administration Department of UT-Ladakh, vide OM No. M/12/34/2024-GAD SEC dated 09.12.2024, requested all Administrative Secretaries to furnish details of all employees substantively holding the post of Section Officer by 15<sup>th</sup> December, 2024.

Whereas, in response to the above OM, the concerned Administrative Secretaries submitted the required information, which was subsequently examined by the General Administration Department for the formulation of a common seniority list of the Section Officers.

Now, therefore, the Provisional Common Seniority List of Section Officers of the Heads of Departments, as it stood on 01.01.2025, is hereby circulated as an Annexure to this OM for information and reference of all concerned.

Any Section Officer who wishes to challenge their assigned position in the seniority list may submit a representation/objection, along with documentary proof, to the respective Administrative Secretary within 15 days from the date of this notification.

The Administrative Secretaries shall review and forward the representations with specific recommendations to the General Administration Department within **21 days** from the date of this OM. No objections shall be entertained after the expiry of this period. Fresh cases for inclusion in the seniority list, if received in the future, shall be examined separately.

The seniority list is subject to the outcome of any writ petition(s) pending before the competent Court(s) of Law.
