### Notification Ladakh, the 15<sup>th</sup> of February, 2025.

**S.O. 16.**— In exercise of the powers conferred by provisos to sub-section (1) and sub-section (2) of section 64 of the Bharatiya Nagarik Suraksha Sanhita, 2023 read with S.O. 2506 (E) dated: 28.06.2024 issued by the Ministry of Home Affairs, Government of India, and in supersession of S.O. 50 dated 03.07.2024; the Administration of Union territory of Ladakh hereby makes the following rules, namely:

#### 1. Short title and commencement:

- (1) These rules may be called the "Service of Summons Rules, 2025".
- (2) They shall come into force on the date of their publication in the Official Gazette.

#### 2. **Definitions:**

- (1) In these rules, unless the context otherwise requires:
  - (a) "Sanhita" means the Bharatiya Nagarik Suraksha Sanhita, 2023;
  - (b) "**Register**" means Register maintained under rule 524 of the Police Rules,1960;
  - (c) "Form" means a Form-1 appended to these rules.
- (2) All the words and expressions used and not defined in these rules but defined in the Sanhita shall have the same meaning as assigned to them in the Sanhita.

#### 3. Summons Register:

- (1) The summons shall, if practicable, be served personally on the person summoned, by a police officer, by delivering or tendering to him one of the duplicates of the summons.
- (2) Every police station shall maintain a register in the format as specified in **Form-1**, in respect of every person to whom summons by the Courts are issued, either through physical or electronic mode in order to enter the address, email address, phone number and such other details, as required by sub-section (1) of section 64 of the Sanhita.
- (3) Summon bearing the image of Court's seal may also be served through electronic communication i.e. via personal messaging app, email etc.

Provided that any action taken or order issued under the S.O. 50 of 2024 prior to the notification of these rules shall, in so far as it is not inconsistent with the provisions of these rules, be deemed to have been taken or issued under the provisions of these rules.
