Whereas, pursuant to the recommendations of the Staff Selection Commission, among others, 04 candidates were provisionally selected as Store Khalasi in Industries & Commerce Department UT Ladakh in level- SL- 1 of pay matrix (₹14800-47100).

Whereas, Industries & Commerce Department UT Ladakh vide Memorandum No. A/1661/2024-I&C SECTION dated:24.02.2025 issued an offer of appointment to the candidates selected provisionally for the posts of Store Khalasi with the directions to submit the acceptance undertaking within 30 days from the issuance of memorandum.


