Subject: Circuit Sitting of CAT Jammu Bench at Leh on 30.04.2024....reg.

The Deputy Registrar/Head of Office, *Bijay Jha*, Central Administrative Tribunal (CAT) Jammu Bench has intimated to this Office that **Hon'ble**Shri Sanjeev Gupta, Member (Judicial/HoD) CAT, Jammu Bench, Jammu & Hon'ble Mrs. Pragya Sahay Saksena, Member (Administrative) CAT, Jammu Bench, Jammu, will be visiting Leh, U.T. of Ladakh, for the Circuit Sitting scheduled to be held on 30.04.2025; and has requested to make necessary arrangements in this respect the Circuit Sitting of CAT Jammu Bench at Leh shall be held at the ADR centre, Leh (UT of Ladakh).

In this regard, it is required that:

- a) The Power Development Department (PDD) Leh, ensure the electricity supply remains continuous during the Circuit Sitting scheduled for **30.04.2025**. In this regard, the Department may depute the concerned JE to carry out any necessary repair and maintenance works, to avoid any disruption during the Sitting, as the proceeding will also be conducted in virtual mode at the location.
- b) The Sr. Superintendent of Police Leh, to monitor all the security measures to be taken concerning the Circuit Sitting scheduled to be held on 30.04.2025 and provide appropriate security at the location for the CAT Members, and the Court.
- c) The State Information Officer, NIC to ensure the proceedings be conducted smoothly in virtual mode, during the Circuit Sitting scheduled to be held on 30.04.2025. NIC may depute the concerned experts/team to complete any related work beforehand and remain present during the Sitting.

- d) *The Chief Medical Officer (CMO),* Leh to depute a medical team to remain present with essential medical supplies during the Circuit Sitting.
- e) *The Municipal Committee,* Leh with a request to direct the concerned staff to clean the premises during the Circuit Sitting.



Sub:-Circuit sittings -Request is to issue necessary directions to all quarter concerned With regard to make necessary arrangements vis-a vis to declare the Hon'ble Mr. Sanjeev Gupta, Member (Judl.)/HoD and Hon'ble Mrs. Pragya Shay Saksena, Member (A) as State Guest reg.

Respected Sir.

I am directed to refer to the subject cited above and to state, that after the abrogation of Article 370, the Central Administrative Tribunal (C.A.T), Jammu Bench was established in the year 2020, and, on the same lines the C.A.T Srinagar Bench was established in the year 2021. As a corollary, a large amount of cases were subsequently transferred to the C.A.T from the Hon'ble High Court. The Union Government entrusted the jurisdiction of Leh to the Jammu Bench, and that of Kargil to the Srinagar Bench. There are considerable number of cases pertain to Ladakh region, situated in hinterlands, which is extremely remote, and the litigants are required to travel all the way to Jammu for hearings and proceedings.

Hence, in order to secure the ends of justice and to allay the hardships faced by the litigants, the authorities have decided to hold circuit sittings at these locations again in the window of April to October by the Regional Benches, possessing the relevant jurisdiction. This decision has been approbated by the C.A.T. Principal Bench, Hon'ble Supreme Court, and the Government of India. The schedule of sittings for calendar year, 2025 had already been approved by the competent authority. The ist, circuit sittings is cheduled to be held on 30th. April, 2025 . So for as the court room is concerned, this Bench has already

In furtherance of it this time all supporting staff shall be travelling by Air and there is requirement of two MTSs staff from your side. Tour programme will be circulated in due course, please.
