Notification

Ladakh, the 30th April, 2025

- **S.O. 50** In exercise of the powers conferred by sub-section (2) of section 9 of the Manoeuvres, Field Firing and Artillery Practice Act, 1938, the Administration of Union territory of Ladakh authorizes the carrying out of the field firing and artillery practice throughout the area notified vide S.O. 09 dated 13.01.2025 for a period of ten (10) years with effect from the date of publication of this notification in the official Gazette of Union territory of Ladakh. Based on the agreement (*copy annexed*) arrived among the army authorities, revenue department and public of the area, the authorization to carry out the field firing and artillery practice in the notified area shall be subject to the following conditions:
 - (i) The Range shall not be used for field firing practice during January to March and during October to November.
 - (ii) The Army shall take all possible measures to prevent loss of life, livestock, public / private property and damage to standing crops. Further, no fencing shall be constructed in the range boundary.
 - (iii) The Army shall make adequate arrangements regarding medical facilities including doctors and ambulances during the days notified for firing.

MINUTES OF MEETING

To resolve the conflict over the firing range located at Tamduk/Chakthal area (also known as Mahe Field Firing Range, Nyoma, a meeting was held on 28/04/25 at 11 AM in the SDM office where discussions happened between 2 representatives of the Army (254 brigade)-(Col Kedar Markale Comdt,6 Lancers, Lt. Col Adhiraj Majumdar) and 2 representatives of the village (Mr Padma Namdol, Village Nambarar and Mr Khandap Dorjee, Tibetan Refugee representative (representative of Reboos)) in the presence of the civil administration.

The village representatives agreed that Tamduk/Chakthal area (also known as Mahe Field Firing Range, Nyoma to Indian Army) serves as a seasonal residence of their nomads and Reboos. The period of utilization of this area by the Reboos is from January to March end and October to November end.

The village representatives have discussed all this with the villagers and the Reboos and has the consent of all stake holders.

The Army representatives agreed with this demand of villagers.
